THE HON. WILLIAM H. ABRASHKIN (RET.)

Throughout his career, the Hon. William H. Abrashkin (ret.) has made mediation and other forms of dispute resolution a central focus of his work. As a member of the Supreme Judicial Court Committee on Alternative Dispute Resolution, Judge Abrashkin helped to formulate the standards and rules for court-connected ADR, and also served as civil program co-chair of the Flaschner Judicial Institute Committee on Judicial Involvement in Settlement. As First Justice of the Housing Court, Western Division, he expanded and supervised an ADR program in his court that resolves a high volume of disputes, including many contract, premises liability, discrimination, zoning, and other cases, in addition to the court's landlord/tenant caseload. In 2007, Judge Abrashkin received the Judicial Excellence Award from the Massachusetts Judges Conference, of which he remains a member.

After 22 years on the bench, Judge Abrashkin was appointed Executive Director of the Springfield Housing Authority, in which position he served for 10 years, until 2018. Through 2020, he served as Interim Executive Director for two additional housing/redevelopment authorities in the western Massachusetts region. He has taught trial practice at the Western New England School of Law, and has published a number of articles in legal journals and a chapter on the Law of Sales in the Massachusetts Practice series. In 2014, he was named as a Purpose Prize Fellow by the national organization, Encore.org, for his "outstanding contributions to solving challenging problems in the second half of life," based on his work on education of low-income children.

A graduate of Columbia College and the Western New England University School of Law, *cum laude*, Judge Abrashkin served as Editor-in-Chief of the Western New England Law Review, and he has served on many boards, including *Massachusetts Lawyers Weekly* and the *Massachusetts Law Review*.

Jeffrey Alitz chairs the construction and design law section of the national law firm of Freeman, Mathis & Gary, LLP, where he is a partner in the Boston office. For the seven-day mediation of claims arising from the design and construction of a Cambridge, MA powerplant; For the mediation of claims resulting from the construction and operation of wastewater facilities in Hooksett, NH and Winchester, NH, and others throughout New England; and, For the mediation of cases in Massachusetts that concern the development and construction of multi-unit residential projects and condominium projects throughout the state.

Mr. Alitz's construction and design practice consists of representing business corporations of all types, including general contractors, subcontractors, owners, developers, suppliers and sureties. He often is called upon to review construction contracts, policies and procedures, and develop preventative strategies to reduce the likelihood of litigation. He also handles construction defect cases and tort claims arising out of construction site accidents. In 2013–2019, Mr. Alitz was recognized as a Massachusetts Super Lawyer by *Law & Politics* magazine in the areas of construction litigation and professional liability defense.

THE HON. JUDITH C. CUTLER (RET.)

The Honorable Judith C. Cutler (ret.) served on the Massachusetts Land Court bench for ten years, first as Associate Justice, and, more recently, as Chief Justice. Her extensive experience in land use and property matters, as well as municipal law, ideally position her to offer case evaluation and mediation services in a broad range of legal disputes, including public sector disputes involving cities and towns.

During her time on the Court, Judge Cutler presided over a broad spectrum of subdivision and zoning appeals, adverse possession claims, easement and boundary disputes, land registration cases, partition cases, condominium disputes, and tax title matters.

Judge Cutler brought to the bench an extensive background in real estate and development. She holds both a J.D. from Suffolk University Law School and a Masters in Community Planning from the University of Rhode Island. She headed the Planning Department in Concord, Massachusetts for more than ten years before starting her legal career at Kopelman and Paige, PC. There, she practiced municipal law for nineteen years, first as an associate and then as a principal, representing municipalities before the trial and appellate courts, and advising cities and towns on municipal authority, obligations, and procedures relative to such matters as public and private ways; licensing; zoning; comprehensive permits; subdivision control; acquisition, disposition, and control of public land; tax title; earth removal; and sign regulation. After retiring from the bench, Judge Cutler returned to KP Law, the successor to Kopelman and Paige, taking on an “of counsel” role for four additional years.

Judge Cutler’s professional memberships include the Massachusetts Bar Association, the Real Estate Bar Association, and the Abstract Club. She is also a member of the American Law Institute, where she has been serving as an Advisor on the 4th Restatement of Property Law project since 2016.

Larry DiCara is among Boston's most recognized civic leaders. A frequent speaker at colleges, universities and other venues, as well as a regular go-to source in Boston media, Mr. DiCara has taught at Harvard, Boston University and the University of Massachusetts. For more than 40 years, Mr. DiCara has practiced real estate and administrative law and has been intimately involved with the development process in and around Boston.

In addition to practicing law, Mr. DiCara has also taught at Harvard University, Boston University, and the University of Massachusetts Amherst. From 1972 to 1981, DiCara was a member of the Boston City Council. In 1978, he was the Council President. When he took office at the age of 22, he became the youngest person to ever serve on the Boston City Council. In 1978, DiCara was President of the Boston City Council, as well as a candidate for Treasurer and Receiver-General of Massachusetts. He finished second in the Democratic Primary behind incumbent Robert Q. Crane. In 1983 he was a candidate for Mayor of Boston. He finished in fourth place with 9.09% of the vote. In 1992, he was an unsuccessful candidate for Chairman of the Massachusetts Democratic Party.

Mr. DiCara has degrees from the University of Massachusetts, LL.D., (Hon.); Harvard University, John F. Kennedy School of Government, M.P.A.; Suffolk University Law School, J.D.; and Harvard College, A.B., *cum laude*. In 1966, he attended Massachusetts Boys State and was elected to represent Massachusetts at American Legion Boys Nation. A graduate of the Boston Latin School, Mr. DiCara is a native of Dorchester and currently resides in Boston.

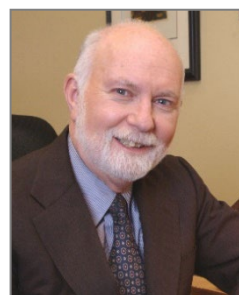

At the request of corporate clients, she also conducted internal investigations. Judge Green first joined legacy Hale and Dorr in 1982. She was elected junior partner in 1988 and senior partner in 1990. She co-chaired the firm's Litigation and Controversy Department of more than 400 lawyers and served on its Executive Committee. She also chaired Hale and Dorr's Litigation Department, was a director of various organizations, including CareGroup, Inc. and Fiduciary Trust Company, and served on state and federal committees on alternative dispute resolution.

In the mid-1980s, Judge Green served as an Assistant U.S. Attorney and Deputy Chief of the Civil Division of the U.S. Attorney's Office in Boston, and in 1993, as Chief of Staff to Massachusetts Governor William F. Weld. From 1993 to 1996, she served as the Deputy U.S. Attorney for the federal District of Massachusetts.

In private practice, Judge Green was consistently recognized by clients and peers as a litigation leader in *Best Lawyers in America*, *Chambers USA: America's Leading Lawyers for Business*, *Boston Magazine*, and other publications. She was listed in the 2004-2016 editions of *New England Super Lawyers* and featured in the 2015 edition. THE HON. R. MARC KANTROWITZ (RET.)

The Hon. R. Marc Kantrowitz (ret.) served as an associate justice in both the trial court and Appeals Court, where he handled scores of land use related cases. In 2015, three days after leaving the bench, he was in Athens, Ohio, serving as a visiting professor/scholar at his alma mater Ohio University, both lecturing and teaching for the fall semester. The course he taught centered around his most recent book, *Old Whiskey and Young Women: American True Crime Tales of Murder, Sex and Scandal*.

In addition to his non-legal writing, which includes three other history related books, Judge Kantrowitz is the most highly published attorney in the Commonwealth on state law. He has either authored or co-authored books on criminal law, motor vehicle tort law, juvenile law, evidence, and mental health law. He has also written numerous law-related articles and chapters.

While a judge, he served on several SJC committees, most notably as a member of the Model MurderManslaughter Jury Instructions Committee; as a member and acting chair of the Bishop-Fuller Committee, established to develop protocol concerning the rights of criminal defendants to review the psychiatric records of complainants who sought psychiatric care; and, perhaps most tellingly, he created and chaired, for several years, the Advisory Committee on Massachusetts Evidence Law, established to assemble the current law into one easily usable document. The Massachusetts Guide to Evidence (Flaschner), created under his guidance, is a mainstay, along with his Criminal Law Sourcebook (MCLE), in courts throughout the Commonwealth. He has also taught at various local institutions and currently teaches criminal trial advocacy at Northeastern University's School of Law.

From 1972 to 1985, Kantrowitz served in the United States Army Reserves, leaving as a Captain in the Quartermaster Corps. He earned a B.A., cum laude, from Ohio University, an M.A. in political science from Ohio University, and a J.D. from the University of Toledo College of Law.

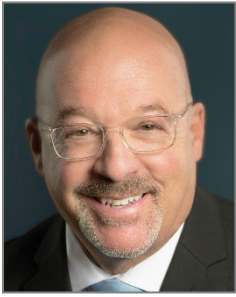

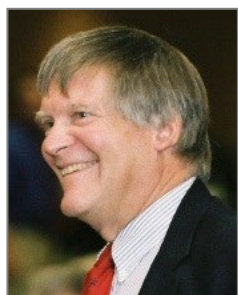
